1.0 APPLICATION AND PAYMENT PROCESS

1.1 Application Process

The applicant is requested to carefully read the application and payment process plan, fill the application form and send it back to the College (CCOD);

- a) You must make a cash deposit of **GHC 200.00** into the University's account (No. 6011702783, Zenith Bank, Sunyani) and attach the pay-in slip to the form before submitting it, or make a cash payment of the above stated amount at the University's Administration (Asaase Aban Building – Second Floor, Sunyani) when submitting the form.

1.2 Payment Procedure

Option 1: The course fee can be paid by bank transfer into the University College for Community and Organization (UCCOD), GHS Account No. 6011702783 (Current Account), Zenith Bank, Sunyani Branch, or GHS Account No. 500875 at Sahel Sahara Bank, Sunyani.

In *exceptional circumstances* **Option 2** may be used to settle course fees.

Option 2: The course fee can be paid at campus during the opening ceremony or on the first day of the module if notice is given to the Registrar at the secretariat. Participants intending to use this option must send a formal signed letter from the Head of their Organisation or Referee confirming that sufficient funds have been allocated to cover the course fee and all related costs of the training, one week before each scheduled course.

2.0 Fees Payment plan

The fee for the PGDOD programme is **GHS 7,600.00 (payable in 3 installments)**, **Top up for MSc is GHS 7,600.00 (payable in 2 installments)** and MSc is **GHS 12,000.00; payable in 4 installments** (Dual Certificate ODCC and MSc OD). Get 5% discount (reduction) for one time-full payment. The duration for the PGDOD/MSc is 15-24 months with 3 consulting encounters (practicum) and Coaching & Mentoring sessions. Each session is 15 days intensive training, interaction, guidance and knowledge acquisition/skills development.

3.0 Refund

Course contribution fees will only be refunded when an applicant informs the University by email, of his inability to attend the course/session at least one week before the course begins. The University will charge 5% processing fee and will not be responsible for any bank transfer charges incurred.

4.0 Method of Delivery

Our method of delivery is **FACILITATION**; using experiential learning and practicing reflective learning theories and models. We focus on the learner experience, and develop their competencies using the right tools in the field of OD as a behavioural science. Definition of OD: **“Organizational Development (OD) is an applied behavioural science that is focused on the organization as a system (people, tools & legacy). The system is transformed after the intervention.”**

5.0 Liable

CCOD shall not be responsible for any negligence on the part of any applicant during application submission. The applicant shall be responsible for whatever information provided. The guideline for NAB/NCTE (NAB/INFO.A.3) is applicable for admitting professional/academic students in all academic programmes.

6.0 Futuristic

CCOD is severally responsible for introducing new and innovative programmes to the current modules with its affiliates (IOD-USA, UDS, etc). It reserves the right to change course fees when the need arises.

7.0 National Accreditation (NAB), Partnership and Affiliation

CCOD is accredited by the NAB to run the MSc OD programme and Affiliated to University for Development Studies (UDS). CCOD is also in partnership with Institute of Organisation Development (IOD-USA) as the representative (franchisee) and a premier OD Technical University in Africa running certification in ODCP, ODCC, BSc and MSc in OD.

8.0 Who should take this course?

First degree from any recognized institution (NAB qualification guide applied): Top Executives, Leaders, Heads of Security, Teachers, Auditors, NGOs workers, Academia, Politicians, Media Professionals, Consultants, agriculturalists, Entrepreneurs, etc.

Those who want to pursue graduate studies in OD to the Masters level, who may have other relevant qualification may apply through professional or direct entry points.

There is also an opportunity for post HND holders and Certified Professional OD Consultants.
